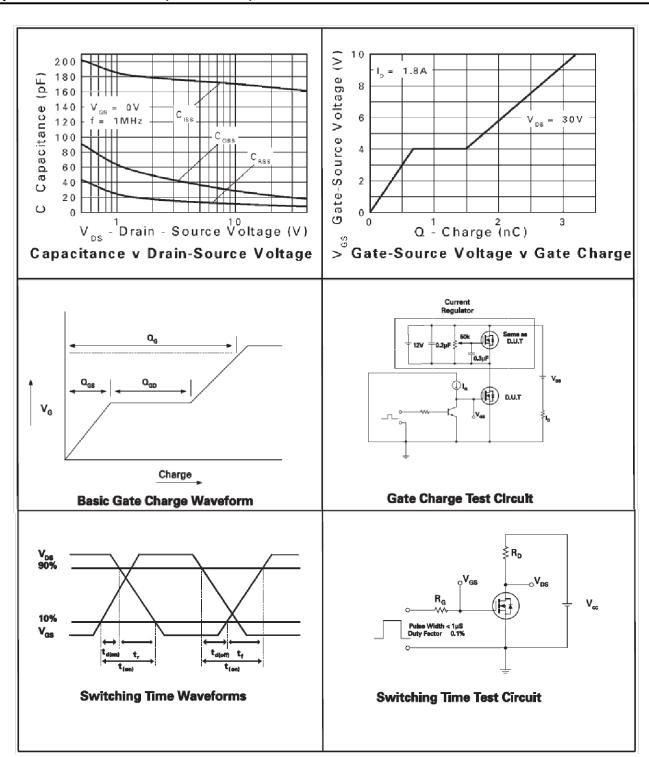


Typical Characteristics (N-Channel)





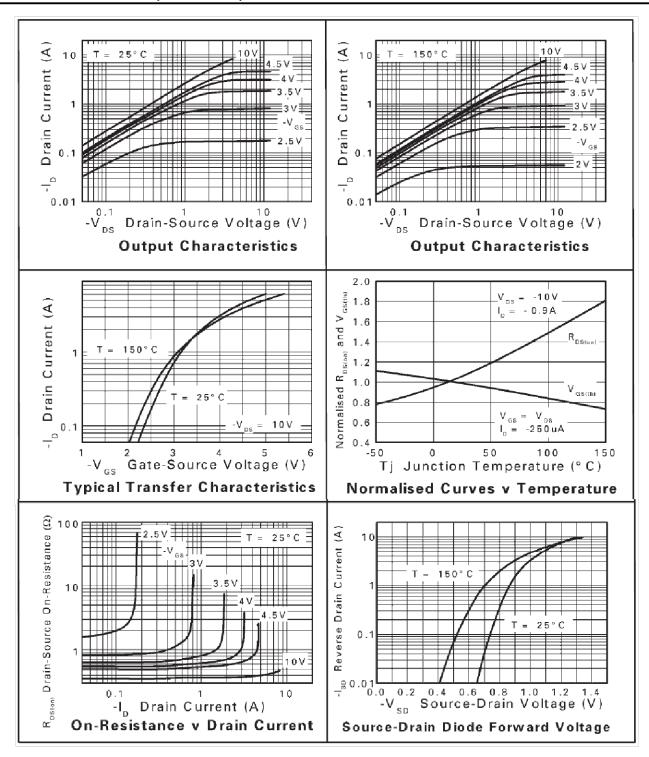
Typical Characteristics (N-Channel)





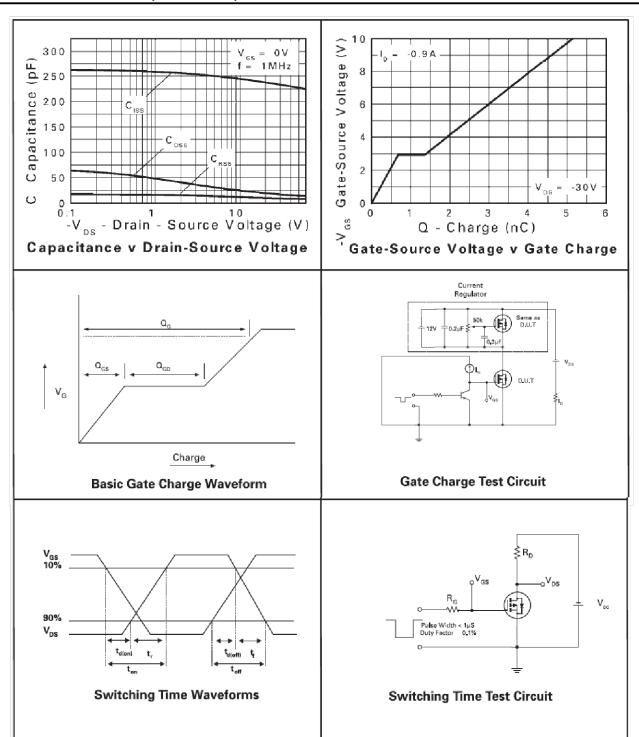


Typical Characteristics (P-Channel)





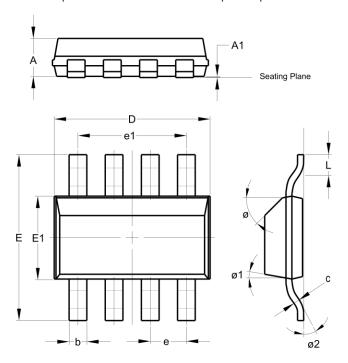

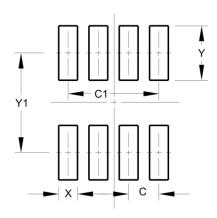
