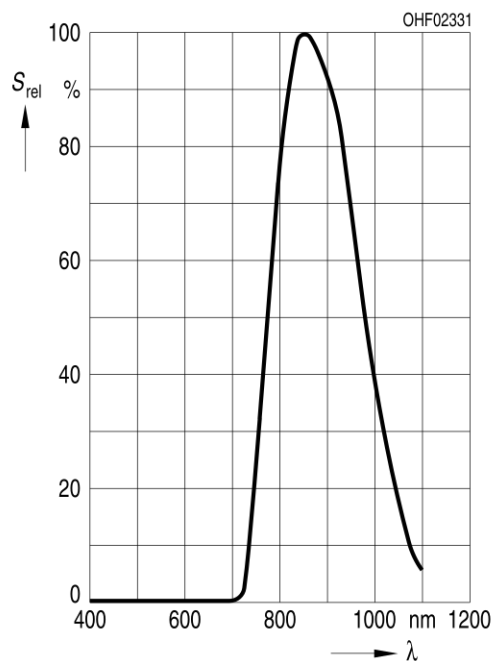

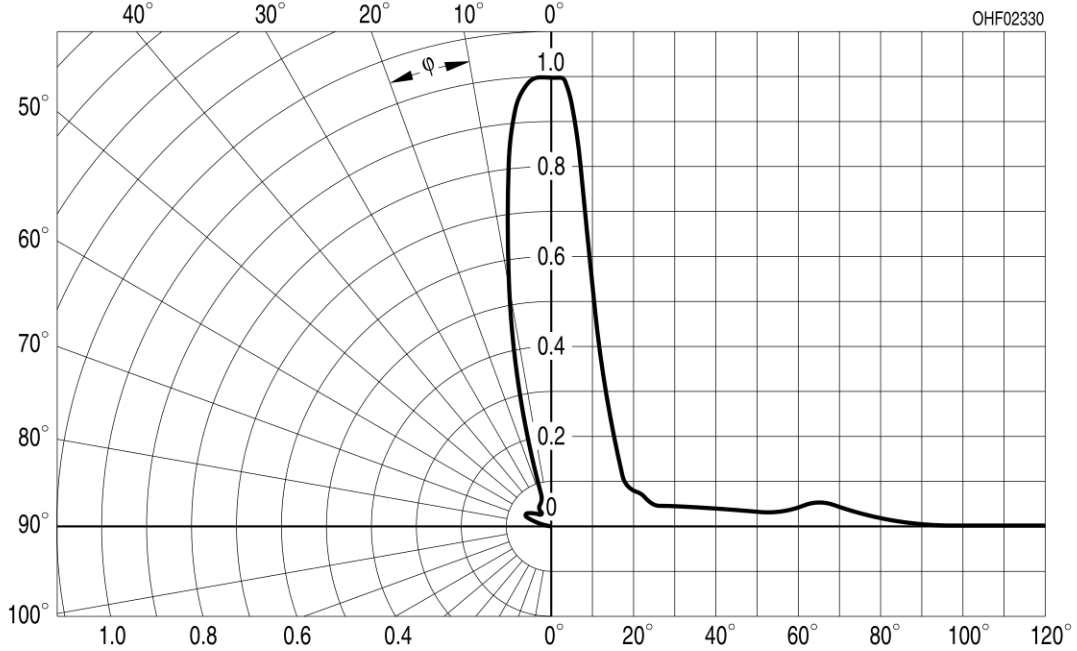
Relative Spectral Sensitivity ^{4), 5)}

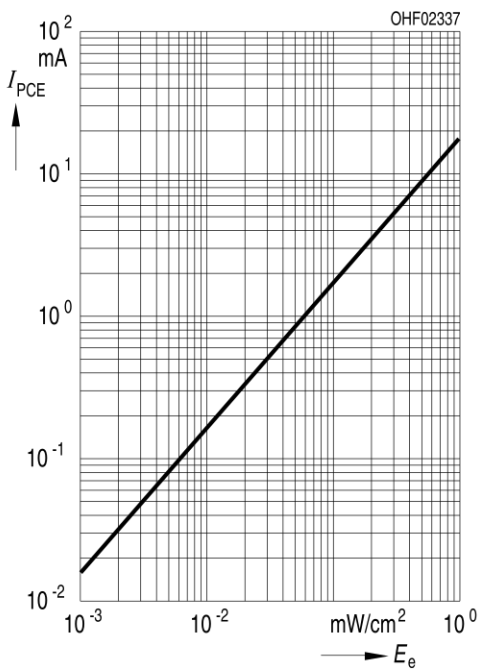
Directional Characteristics 4), 5)

$S_{rel} = f(\varphi)$



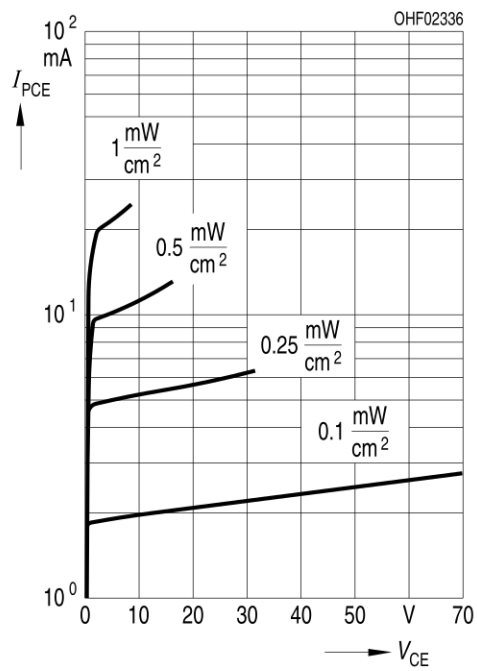

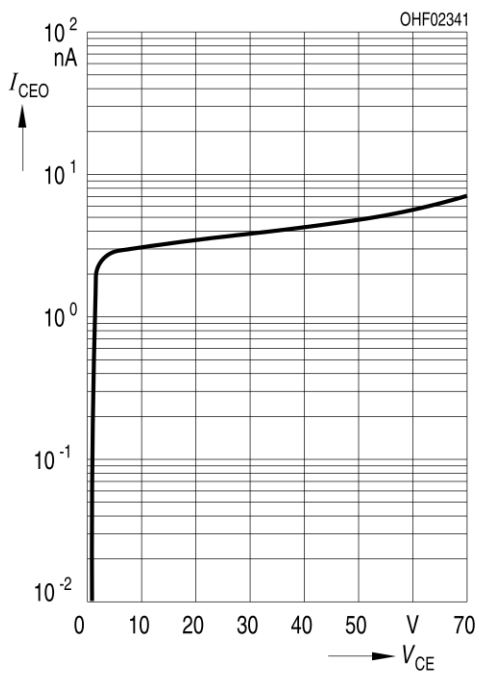
Photocurrent 4), 5)

$I_{PCE} = f(V_{CE}); E_e = \text{Parameter}$



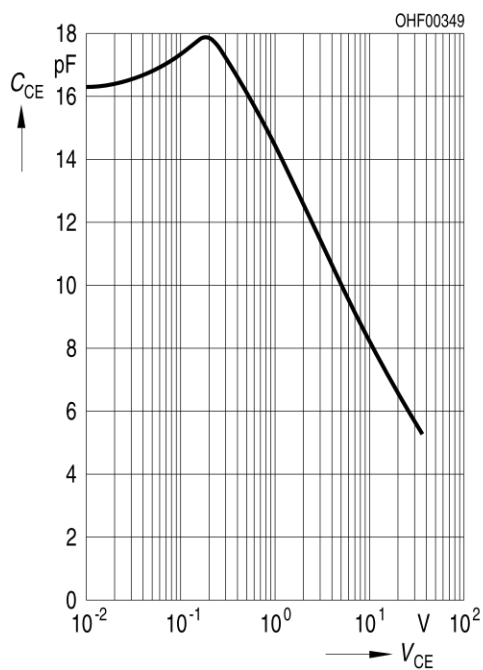
Dark Current 4), 5)

$$I_{CE0} = f(V_{CE}); E = 0$$



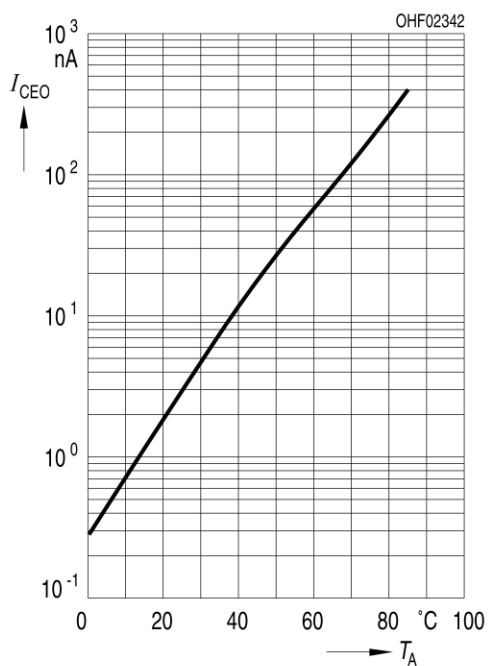
Collector-Emitter Capacitance 4), 5)

$$C_{CE} = f(V_{CE}); f = 1 \text{ MHz}; E = 0$$



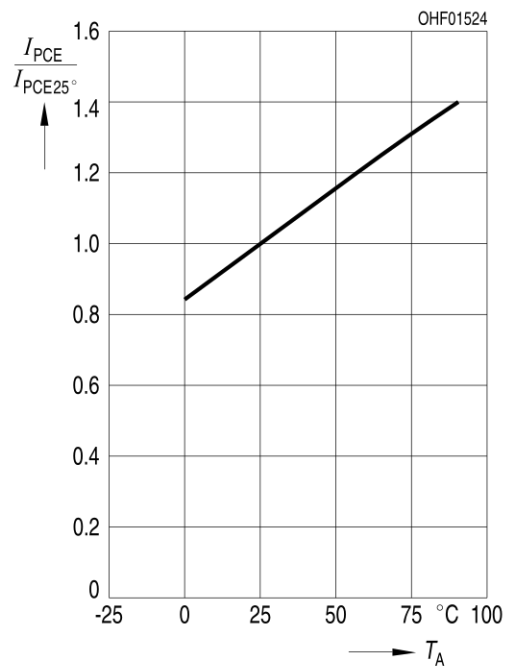
Dark Current 4)

$$I_{CE0} = f(T_A); V_{CE} = 5 \text{ V}; E_e = 0 \text{ mW/cm}^2$$



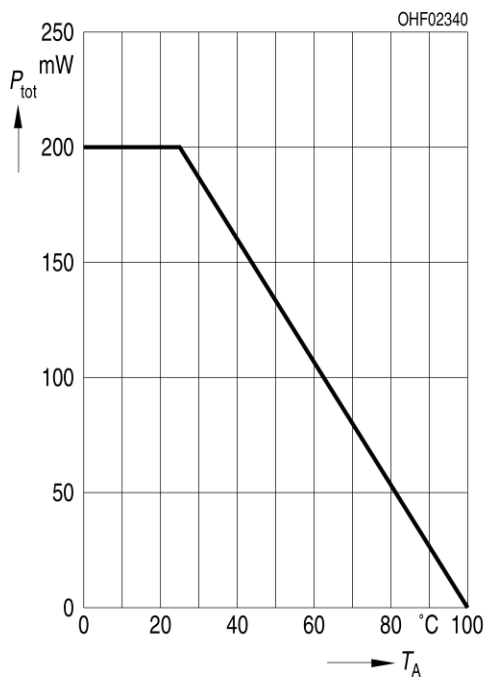
Photocurrent 4)

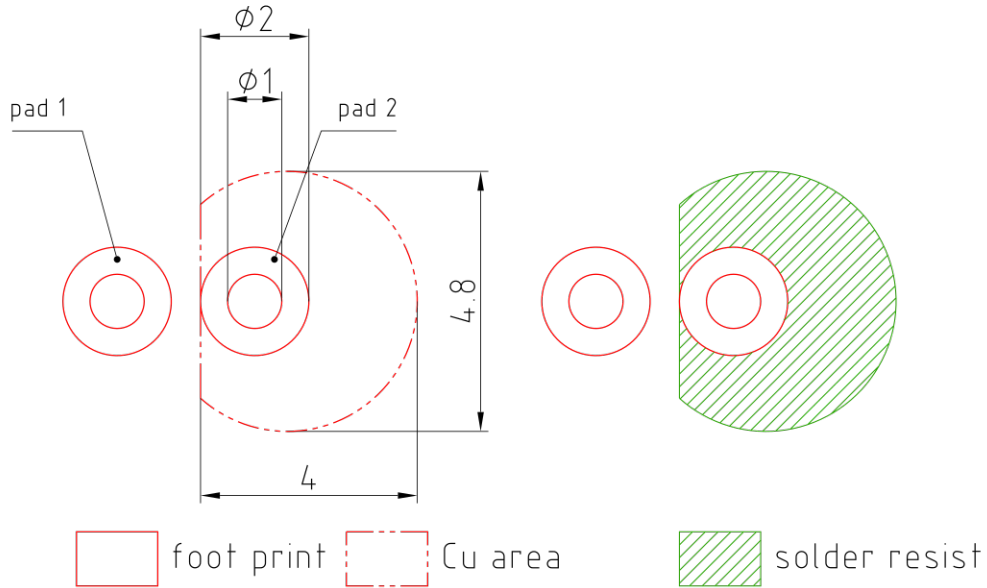


Power Consumption

Recommended Solder Pad ⁶⁾

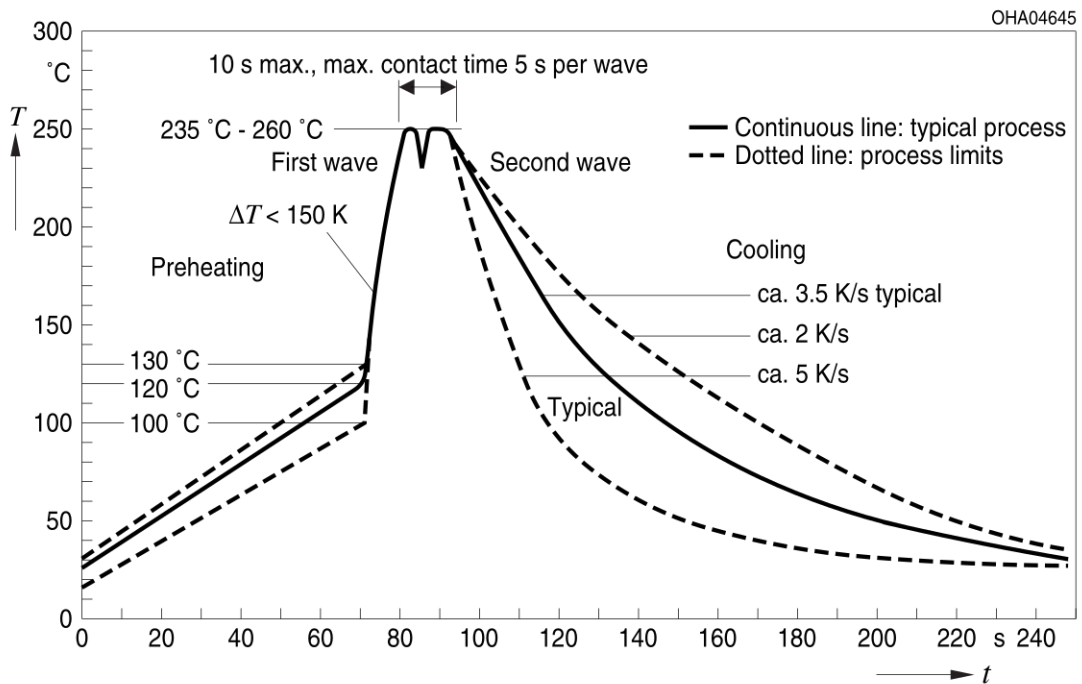

Notes
