



 $S_{rel} = f(\lambda)$ 





## **Directional Characteristics** 2), 3)




### Photocurrent 2), 3)


### Dark Current 2), 3)


# Collector-Emitter Capacitance 2), 3)

$$C_{CE} = f(V_{CE}); f = 1 MHz; E = 0;$$









## Dimensional Drawing 4)




